14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ **On February 23, 2018, The Waddell & Reed Advisors Wilshire Global Allocation Fund merged into the Ivy Wilshire Global Asset Allocation Fund in a tax-free merger. As a result of the reorganization, the shareholders of all classes of the Waddell & Reed Advisors Wilshire Global Allocation Fund exchanged their shares to the Ivy Wilshire Global Asset Allocation Fund equal in value to the aggregate net asset value of the shares surrendered.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **Each share of The Waddell & Reed Advisors Wilshire Global Allocation Fund (merging fund) is being replaced with shares of the Ivy Wilshire Global Asset Allocation Fund (acquiring fund), at a ratio noted in the attachment for each share class. The basis of the shares received is the same as the aggregate of the shares exchanged. However, the cost basis per share of the Waddell & Reed Advisors Wilshire Global Allocation Fund has changed based upon the number of shares exchanged to the Ivy Wilshire Global Asset Allocation Fund.**
